09:05-12:05 Workshop on the use of the DSS

Ahmad Manschadi (BOKU) and Thomas Neubauer (TUW)

A hands-on workshop on the usage of the intercrop model and decision support tool, with opportunity to ask questions and debate issues.

12:05-12:35 Suggestions and Comments by Industrial Advisory Board

This is a specific session for the IAB to give feedback on the project, its advancements and give suggestions and recommendations regarding any aspect.

13:30–14:30 Networking session with other related projects (IntercropValuES, VALERECO, LEGENDARY)

The sister project IntercropValuES and the two related VALERECO and LEGENDARY will present themselves (up to 15 minutes each) to the consortium; then there will be a discussion on potential further (further) collaboration and joint activities.

14.30-15.00 discussion on role and management of Living Labs; what's next?

The discussion starts from the idea of creating some structure in order to keep LLs alive after the project, possibly if there are issues that farmers still find important and keep an interest in spending time on. Some LLs could also be (come) lighthouses, institutions showing machines, techniques, practices and fostering connections with industry, where farmers can learn about practices without having access to universities or other teaching-focused institutions. The discussion about how to keep LLs/lighthouses alive is also in view of the potential participation in further projects.

15:00–16:15 ‘focus groups’ discussion about project development and risks

- *The session starts with the division of participants into 3 groups, corresponding to the 3 components: 1) Research (led by LUH and UNIFI) 2) Dialogue (led by IFAU, ESCI and AU) 3) Tools (led by TUW, BOKU and FE).*
- *Each group has 30 minutes to discuss the point reached and possible risks or threats that should be overcome or mitigated in the last year of the project, also taking into consideration the recommendations by the IAB*
- *Plenary: each group presents their conclusions (5 minutes each, total 15)*
- *General discussion and conclusions relevant for the progress of the whole project.*
